

What is an Invention Report?

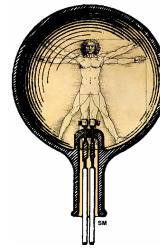
An invention report is the thorough documentation of a new product designed by a professional technical writer. It can include a comparison of competing patents, a glossary of terms, and drawings. Invention reports provide the patent attorney with complete and accurate information for a patent application at lower cost to the inventor.

Invention reports are commonly used by academic/research institutions and high-tech companies as the necessary first step on the path towards a comprehensive and secure patent.

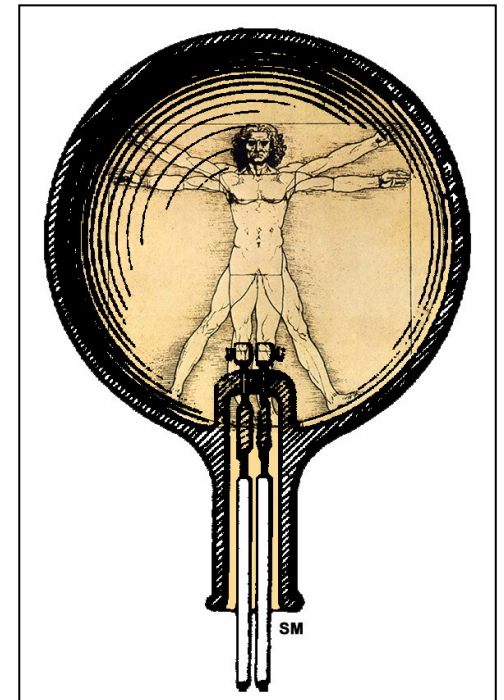

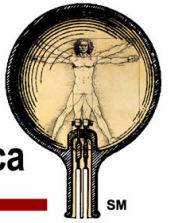
